Memorandum of Understanding

This **Memorandum of Understanding** (hereinafter referred as "MOU") is made at **Mumbai** on **15th Day of May, 2026** ("Effective Date") **BY AND BETWEEN**

Saifee Hospital, promoted by Saifee Hospital Trust incorporated under Bombay Trust Act, 1950 bearing registration no. E-5448 (Bom) having its facility at 15/17, Maharshi Karve Marg, Mumbai - 400004 (hereinafter referred to as "**the Hospital**" which expression shall unless repugnant to the context or meaning thereof be deemed to include its successors and permitted assignees) **of the First Part;** and

Federation of Cuffe Parade an having its registered office at Sunflower Apartment, 99, G D Somani Road, Cuffe Parade, Mumbai 400 005(hereinafter referred to as "**FCP**" which expression shall unless repugnant to the context or meaning thereof be deemed to include its successors and permitted assignees) **of the Second Part.**

The Hospital and FCP are, wherever the context so require, hereinafter collectively referred to as the "**Parties**" and individually as a "**Party**".

NOW, THE PARTIES DO MUTUALLY AGREE AND HAVE ARRIVED AT AN UNDERSTANDING AS INDICATED BELOW:

1. Purpose:

FCP shall recommend the members of its federation to the Hospital and the Hospital agrees to provide Inpatient, OPD treatment, Health Check-up services and other agreed healthcare related advice/consultation for the members of the FCP as stated in "**Annexure A**".

2. Commencement Term:

This MOU shall be in force from **15th Day of May, 2026** and shall remain in force unless terminated earlier in terms of Clause 7 of this MOU.

3. Hospital's Obligations:

3.1. The Hospital agrees to provide Inpatient, OPD treatment, Health Checkup services and other medical treatment (if required) for the members referred by FCP.





3.2. The Hospital agrees to give preference on admission and hospitalization to all members referred/connected by FCP .

4. Obligations:

4.1. FCP shall recommend the members for treatment to the Hospital.

4.2. FCP agrees that all its members will show the membership card/authority letter to avail the facility at the Hospital on discounted fees.

4.3. The discount mentioned in “**Annexure A**” will be provided to the members of FCP only if they have approached Saifee Hospital directly and not if they have been referred by any other individual or healthcare agency.

5. Independent Parties:

Hospital and FCP are and at all times shall be, independent parties in all matters relating to this MOU.

6. Fees:

The interim and final bills will be submitted by the Hospital to the members, which shall include complete and clear break up of services, procedures, tests, pharmacy bills, doctors fees, discharge card. The payment of the bill shall be done as per the Hospital’s policy and shall be the sole responsibility of the members/staffs.

7. Termination:

7.1. Either Party may terminate this MOU or scope of engagement by serving a 90 days written termination notice.

8. Governing Law & Jurisdiction:

8.1. If any dispute arises between the Hospital and the FCP in connection with this MOU shall be referred to arbitration under the Arbitration and Conciliation Act, 1996.

8.2. The jurisdiction over all matters arising in connection with this MOU shall vest exclusively in the courts at Mumbai.





9. Notices:


All notices under this MOU must be in writing and either mailed by certified or registered mail, express courier or hand delivered to each Party as per the communication address provided by the Parties. The Parties will intimate the change of address, email, phone within 10 days of the change to the other Party.

10. Modifications:

All changes, alterations or modifications to this MOU are valid if agreed upon in writing by the authorized representative of both the Parties by entering into an addendum or fresh MOU.
